The work involves cutting of **133 trees** of Peltophorum, Mango, Polyathia longifolia, Mango, Neem, Tamarind, Neredu, Palakodisha, Subabul, Jama, Soppera, China badam, Kigelia, Gulmohar, Soppera etc.,existing in Moosarambagh Part 1 and Part 2 Parking & Clearance area. Metro Rail Corridor- I, to ground level including cutting of trunks, branches and removal of stumps & roots, refilling, compaction of backfilling wherever necessary and carting of serviceable as well as unserviceable material with all lifts as per Technical Specification Clause 201 MORD /

MORTH. The work should be completed within 7 (seven) days from the date of issue of work order.

Terms and conditions:
