**ORDER:**

In the Government Order 1<sup>st</sup> read above, Government have decided to approve the selection of the lowest bidder viz., Larsen & Toubro Limited as the Concessionaire to develop the Hyderabad Metro Rail Project at their quoted grant amount of Rs.1,458crore (Rupees one thousand four hundred and fifty eight crore only) and to award the project to M/s. Larsen & Toubro Limited. Accordingly, Letter of Award was issued to the concessionaire.

2. In the reference 2<sup>nd</sup> read above, the Managing Director, Hyderabad Metro Rail Limited has reported that after issue of Letter of Award for Hyderabad Metro Rail Project and the DBFOT developer being in place, the next important prerequisite for execution of the Project is selection of independent Engineer within 90 days from the date of agreement as per Article 23 read with schedule Q of the Draft Concession Agreement. The Independent Engineer to be selected by the Government to act as an authority for inspection, testing, approval and review of the work of the DBFOT Developer/Concessionaire and for compliance of Agreement conditions by both Concessionaire and the Concessions Authority (GoAP). The Consultancy Evaluation Committee shall be responsible for all aspects and stages of consultant selection i.e., evaluation of the RfQ, short listing of consultants, deciding Terms of Reference, issuance of RfP, evaluation of RfP, negotiations and final selection of the consultant and requested the Government to consider appointing a three member committee consisting of:
