2. Registered contractors who have executed single similar nature of works in electrical worth of **₹ 4.83 lakh** and above during any one year in the last 5 years in his name are eligible.
3. The Bidder should have satisfactorily Constructed / Completed High rise building of not less than **G + 3 Floors** during the last five financial years i.e., from **2008-2009 to 2012-2013**.
4. The Bidder should have executed the minimum quantities of items of work as given below in any one year during the financial **years 2008-2009 to 2012-2013**.
