2. The Contractors should enclose their proof of registration of Class IV & above as the case may be in State Govt.

4. The Tender Schedules are not transferable.
5. Latest income tax/commercials tax clearance certificate, VAT, PAN and Registration copy etc shall be enclosed.
6. Availability of key personnel and critical equipment (either owned or leased) shall be enclosed.

Tenders are to be submitted in a sealed cover along with qualification data viz., Annual Turnover and value of work under execution, Registration Certificate, Experience Certificate, PAN VAT clearance & registration, IT/CT clearance certificates, Key personnel with adequate experience and critical equipment.
