### Eligibility Criteria:

1. Class I : G.O Ms No 94 Govt of AP dated: 01.07.2003
2. Electrical contractor class I with grade 'A' licence
3. PAN allotment reference
4. APGST / VAT registration
5. Registered electrical Class I contractors who have executed single similar nature modern street lighting work (Rs. 47.50 Lakhs) of estimated cost, at least in any one year during the last five years.
6. Contractor should enclose experience certificate of similar works of Government Department duly attested by concerned department Officer not below the rank of the EE and countersigned by the SE concerned.
7. Tenders received without valid experience certificate will be summarily rejected.

### Terms & Conditions:

1. The cost of Tender Schedule is not refundable. It should be remitted by Demand Draft drawn in any Nationalized Bank in favour of Managing Director, HMR.
- 2(a) The Contractors should enclose their proof of registration of Class I in GHMC / State Govt. / Central Govt. with Grade-A licence.
- (b) Experience in single modern Street lighting work worth of estimated cost (Rs. 47.50 Lakhs) at least in any one year during the last five years.
3. EMD @1% should be remitted along with tender application by Demand Draft in favour of Managing Director, HMR.
4. The Tender Schedules are not transferable.
5. Experience details of last five years in similar works in state or Central Govt. department's single modern street lighting work worth of estimated cost (Rs. 47.50 Lakhs) executed should be enclosed.

7. Latest income / commercial tax clearance certificates, VAT, PAN and registration copies etc.
8. Availability of key personnel and critical equipment.
9. Tenders are to be submitted in sealed cover along with qualification data viz., Registration certificate, experience certificate, VAT clearance & registration, Income Tax / Commercial Tax clearance certificates, key personnel with adequate experience and critical equipment.
10. EMD @1.5% should be remitted at the time of the agreement in the shape of Demand draft in favour of Managing Director, HMR
